Supporting the Policy Agenda for Manufacturing

The Federation of Small Businesses in Wales (FSB) has launched a report on the changing landscape facing firms in Wales' manufacturing sector called Manufacturing Momentum. In this report, a number of recommendations and calls to action are proposed.

Manufacturing Wales will support this report by taking a more indepth review of what our manufacturing members feel are the key issues, in order that these views can be shared more widely with policy makers in Wales and beyond.
